
This position allows members to engage in strategic and policy discussions with our Board in a non-voting, volunteer capacity, providing valuable insight and experience.

## Post Your Own Travel Notice

Heading out of town and planning on using your MSEFCU Debit or Credit Card? To ensure your debit and credit cards work smoothly during your travels, use the "Travel Notices" feature in your mobile app or online banking! By letting us know where and when you'll be traveling, we can help protect your accounts from unauthorized transactions and ensure your debit/credit cards work seamlessly during your trip.



#### How to set up a travel notice:

- Navigate to the left dashboard menu and select "Travel Notices"
- Click "Add travel notice"
- If you are traveling within the U.S., you can select up to 5 states you are planning to travel to
- If you are traveling outside of the U.S., you can select up to 5 countries
- Select the date you plan to leave and the date you expect to return
- Ensure that your email and phone number are up to date
- Lastly, select the debit/credit cards you will be using while you are traveling
- Click the save button
- You will have the option to return and edit/delete the travel notice if your plans change

# 2025 Annual Meeting and Election

The Nominating Committee has submitted the following names for the positions currently available for our Board of Directors:

**Susan Walker**, Incumbent - Director Susan Walker grew up in Merced and attended Merced area schools. She worked for the Merced County Office of Education for 30 years and retired December 2008 as the District Services Payroll Manager. She is a past member of the California Association of School Business Officials and was on the Board of Directors for the Merced Girls Softball League for 24 years.

**Alice Nguyen**, Incumbent -Director Alice Nguyen is a Merced native and she earned an AA from Merced College, BA from CSU Sacramento and MPA from CSU Stanislaus. She has over 20 years of combined experience in web development, project management, and digital communication across the higher education, non-profit and private sectors. She currently works as a website product manager in the public sector.

**Richard Rogers**, Incumbent -Director Richard Rogers and his family have been proud members of MSEFCU for over two decades. He received a BA in Public Policy and an MA in Political Science from Brigham Young University, along with teaching and administrative credentials from CSU Stanislaus. He has taught social studies courses at Le Grand High School for nearly 24 years. Nominations and Voting Bylaws

 $Nominations for vacan\'{c}ie\'{s} \textit{ may also be made by petition signed by one percent of the membership. Each nominee by petition and the percent of the membership of the m$ shall submit a statement of qualification and biographical data with the petition. Nominations by petition must be filed with the Secretary of the Credit Union no later than January 20, 2025. Nominations cannot be made from the floor unless insufficient nominations have been made by the nominating committee or by petition to provide for one nominee for each vacancy to be filled. No election will be held if there is only one nominee for each position to be filled. If there are additional nominations by petition for any of the positions to be filled, an election will be conducted by ballot at the annual meeting.
